### Saving democracy from itself

While Ukraine's resistance to Russia's invasion is spearheading Europe's defence against the external menace to freedom and democracy, the continent must remain alert to insidious internal threats.

Recent years have seen a surge in extremist politics and the consolidation of movements opposed to European integration and liberal democracy. April's elections in Hungary and France were just the latest examples of how polarised Europe's politics have become.

Against that background, European Young Leaders (EYL40) gathered in Zagreb for three days of passionate discussion on how to defend and strengthen democracy across the continent and beyond.

They focused their unique talents and diverse experience on ways to build a renewed social contract for Europe that revitalises relations between the public, private and social sectors.

They brainstormed on building a constructive alternative to polarised politics, and debated paths where the arts, media, civil society, education, technology and sport can come together to bolster Europe's hard-pressed democratic values. Few have any illusions over the size of the problem.

The largest war on the European continent since 1945 follows a quickfire succession of

shocks to its political, economic and social foundations: COVID-19, Brexit, refugee crises, financial collapse, recession, and, above all, the climate emergency. Globalisation and geopolitical realignment have left Europe's economy vulnerable to overstretched supply chains. The economic impact of Vladimir Putin's war will be immense for Europe and much of the world.

All this turbulence has left voters bemused. Some are angry, others drift to apathy, convinced that they can do little to effect change. Disorientation is accentuated by rapidly transforming media landscapes marked by opinion-shaping algorisms, fake news peddled by hostile powers or domestic demagogues, or platforms controlled by plutocrats with little to no accountability.

Still there are signs of hope. Europe reacted forcefully to Russia's aggression and (eventually) to COVID-19. The European Union has been armed with new financial powers and a wider healthcare mandate. NATO nations have -mostly - pulled together to stand with Ukraine.

Civil society has stepped up, as citizens united to support healthcare systems and vulnerable citizens through the pandemic, and again to send aid to Ukraine or welcome refugees fleeing the invasion. The EYL40s heard from their peers, including politicians seeking to make a difference, entrepreneurs wielding new technologies for the

benefit of citizens, and artists mobilising culture for the defence of freedom.

Held from 12-14 May in the Croatian capital of Zagreb, the EYL40 seminar marked the full resumption of the European Young Leaders' programme after more than two years of pandemic-imposed limitations. Celebrating its 10th anniversary in 2022, the European Young Leaders (EYL40) selects each year reputed leaders under the age of 40. Coming from a wide range of backgrounds, they also play an essential role of helping to reconnect people with politics, EYL40s represent an alternative infrastructure

of leadership, a new generation of leaders able to inspire action and generate change. Each year, Friends of Europe brings them together in a European capital to strengthen the network and discuss the most pressing issues of our times with each other, EYL40 alumni from previous years and invited experts.

The vitality of the discussion in Zagreb showed that the hiatus spurred on by COVID-19 did nothing to weaken the dynamism of the EYL40 project, generating an outflow of ideas that can shape our European future and underpin a democratic regeneration.

Looking ahead, the seminar produced a number of key ideas to be taken:

- Invest in the civil service: bureaucrats often get a bad rap, but maintaining the quality and quantity of civil servants is essential for healthcare, education, justice, security and other services;
- Develop a multi-stakeholder dialogue on principles to be applied in economic sanctions policy to ensure political, social or economic goals are met, while minimising adverse economic impacts for Europe;
- Reach out to young people who might be tempted to vote for extremist politics; seek to understand their motives and provide alternatives rather than marginalise them;
- Unblock the EU accession process for countries in the Western Balkans;
- Introduce a special tax for tech companies, the proceeds of which can be allocated to a fund that supports free and investigative media;
- Make the directors of social media companies personally responsible for abuses carried out on their networks;
- Build on the Constructive Politics initiative to make a real impact with the cohort of young MEPs set to come in with the 2024 European Parliament election.
- Lobby the EU for the rights for professional sportswomen across the continent, to end discrimination, ensure fair treatment and fair pay;

## Getting constructive on polarisation

On the opening day, the young leaders met with **Andrej Plenković**, Croatian Prime Minister. Their discussion ranged from the impact of the war to calls for an overhaul of the European Union's guiding treaty, but Plenković also zoomed in on the central theme of the seminar: saving European democracy.

He expressed deep concern that social media, falling educational standards and a sharp decline in the quality of political discourse were undermining democratic standards.

"We have political movements, totally destructive ... who gain the confidence of the voters," Plenković cautioned. "It's a threat to democracy, a serious threat. The only way to deal with it is with better and deeper education."

Debate throughout the seminar centred on countering that democratic decline. For example, constructive politics could be used as a pathway to overcome polarisation, and rethinking the roles of the private sector, media, education and the arts in building a

renewed social contract can underpin Europe's democratic values.

Laying out the problem, **Alison Goldsworthy**, Founder and CEO at The Depolarization Project, author of *Poles Apart* and Advisor to the Conflict and Polarization Lab at Stanford University, explained how disagreements over political ideas and visions of society had evolved into "effective polarisation" where divisions run deeper and become more personal.

"The impact of polarisation on our democracies is very profound," she warned. "Polarisation is a big issue. It's spilling over and it's getting worse."

Taking April's French presidential election as a test case, **Nassira El Moaddem**, Journalist, Author and Presenter, Arrêt Sur Images and



2018 EYL40, held President Emmanuel Macron responsible for creating and 'playing with' polarisation in order to gain advantage over opponents.

"Macron, and not only him, the political leaders in general in France play with fire, with this polarisation between far-right and left, and that is a concern for our democracy," she asserted.

By recycling some of the traditional far-right discourse, Macron's campaign and mandate normalised and fed into extremism on one hand and apathy on the other, as voters are forced to choose candidates they dislike the least, rather than one they really support.

The EYL40s put forward a number of ideas to counter the problem.



**Talitha Muusse**, Chief Impact Officer at Bikverruimers – a training programme for young professionals in the Netherlands, Founder of Eneegieboot and 2022 EYL40, urged more outreach to understand why young people are alienated by mainstream politics and turn to the far-right; **Ricardo Baptista Leite**, Founder and President of UNITE, Member of the Portuguese National Parliament and 2015-2016 EYL40, called for greater efforts by moderate parties to attract quality leadership; and **Benjamina Karić**, Mayor of Sarajevo and 2022 EYL40, underscored the importance of promoting diversity, tolerance and multiculturalism.

Several participants recalled that a degree of polarisation is positive and warned that cosy consensus politics can also lead to voter disaffection.

"Polarisation is a key element of democracy. I do believe that it is important that we disagree," contended **Nicolas Brien**, Chairman of the Management Board at EuraTechnologies and 2022 EYL40. "The problem is that, today, we agree too many times on too many things ... Let's disagree, let's clash."

To fix problems afflicting European democracy, Friends of Europe launched a Constructive Politics initiative in 2021. Led by **Kirsten Brosbøl**, Founder and CEO at 2030beyond, former Danish minister for the environment and 2017 EYL40, it aims to arm new politicians with tools to be constructive representatives, helping them to serve their community, work together to solve the big problems of today and tomorrow, and ultimately build back citizens' trust.

Brosbøl wants to overcome divisions and create conditions where politicians work together for the common good, rather than fixating on negative campaigning and backbiting. "We really need to learn new skills about how to avoid falling into the bad habits," she said.

Far from attempting to erase political differences, the Constructive Politics initiative aims to return to a positive dialogue across parties and opinion, for policies that serve the public and society. To that end, *Friends of Europe* is designing a series of items including a 'buddy network' to unite kindred political spirits and an online platform for insights and ideas.

The Zagreb seminar also featured a special working group to thrash out ideas with the goal of forming a bootcamp for newly elected lawmakers in the 2024 European Parliament elections. The bootcamps, designed by Friends of Europe and leading EYL40s of the Constructive Politics project, will be tailored to newly elected parliamentarians across Europe, to give them the necessary tools to wade into often unconstructive environment and construct, with the willing, a constructive political dialogue. These bootcamps will also be open to more seasoned and willing parliamentarians and followed by refreshers, in the hope of becoming a staple for policymakers across Europe.

### The post-pandemic renewed Social Contract

In 2018, Friends of Europe published its #EuropeMatters report, advocating a renewed European Social Contract by 2030. It should frame citizens' lifelong development through childhood, work and old age, covering education, health, civil rights and other key societal elements. It must also address collective challenges, including the environment, public health and security, while remaining rooted in democratic legitimacy.

Much of the Zagreb seminar was concerned with a renewed Social Contract dynamic. One session looked at the role of private sector as companies are called upon to pay a more constructive political and social role, from fighting climate change to putting the economic squeeze on Putin's war machine.

Other sessions examined education, with digitalisation opening opportunities for 'anytime, anywhere learning', and others drew a focus on the free press in its struggle to serve as democracy's watchdog as it faces unprecedented economic pressure and violence from criminal gangs and political thugs.

"Is it time to rethink the role of the private sector?" asked **Dharmendra Kanani**, *Friends of Europe*'s Chief spokesperson and Director.

"With Ukraine we've seen how people power ... can urge corporations to do the right thing, to pull out of Russia," he said. "The largest companies are having to be thinking very, very seriously about their public-good credentials."

Greater transparency, social-media scrutiny and consumer activism are forcing companies to take a stance on issues like Ukraine and climate change, speakers noted.

"The question of what kind of role business plays in our democracy is an important question that's been overlooked for a long time," argued **Alberto Alemanno**, Jean Monnet Professor in EU Law at HEC Paris, Founder of The Good Lobby and 2014 EYL40. "The moment of truth has finally arrived."

Alemanno pointed to the Good Lobby's work monitoring companies' responses to the Russian invasion as an example of how corporations now have to contend with an 'ecosystem of accountability', obliging them to adapt business policies to consumer pressure.

That includes the complex issue of sanctions compliance in the interconnected world economy, explained **Dominik Kampmann**, Director and Head of Defence, Intelligence and Law Enforcement, Europe and Africa at Moody's Analytics.

"If we talk about social responsibility or the responsibility of corporations right now, I think all corporations across the globe should really screen and check their customers, their entire supply chain, to be compliant with the current sanction regimes," he said by video link from Berlin.

Kampmann urged politicians, corporations and civil society to work together to establish common goals that support social and environmental objectives without undermining economic

progress. "This would be a very important pillar for the stability of our democracy," he concluded.

On education, the group heard how the renewed social contract must build a coherent end-to-end European learning strategy.

The debate looked at the opportunities of digital education that were accentuated during the pandemic but cautioned that to ensure distance learning does not leave poorer, more rural or more marginalised students behind. The role of the private and social sectors in complementing state education was another key issue.

"The digitalisation of education anywhere, anytime has huge potential to help tackle the problems we face now in our societies regarding equality," emphasised **Tatjana Kiilo**, expert in digital education and education strategies from Estonia and former Vice Chair of the OECD Education Policy Committee. "This is a promise of social mobility, the promise of getting better propositions in life, for the labour market, for citizenship, for realisation as a citizen in society." **Nenad Bakić**, Founder and President of Croatian Makers, a philanthropic organisation and the EU's largest extracurricular STEM programme using technology to help children, further insisted that "digital literacy today is basic literacy".

He added that education is key for social mobility. "Education is the tool for equal opportunities, it gives the opportunity for all kids to be equal citizens," Bakić said. "If you go through the list of the richest people in the world, most of them would be self-made men who are well educated."

To level the playing field so kids can make the most of their potential, the European Young Leaders stressed the need to ensure under-privileged children have equal access to digital education, but also get decent housing that enables them to study.

While recognizing the potential of digital, several EYL40s also emphasized the importance of direct contact with teachers and other students in engaging with citizens. They warned against 'digitalisation for its own sake'.

The private sector's role in education was hotly debated. While there was broad support for business playing a supplementary role, speakers urged caution.

"I see a risk in looking to the private sector to plug gaps in this space, there is a danger of ending up with a disparate array of initiatives that aren't joined up," warned **Chris Dixon**, Head of Public Benefit and Global Network Lead at The Vodafone Foundation. "Any involvement of the private sector needs to come hand-in-hand with government, with educational authorities and, importantly, with educators."

The fourth estate will have a key watchdog role under any renewed Social Contract. Despite a slew of bad news about violence enacted on journalists, newspapers folding, fake news, and freedom of speech being squeezed by authoritarian regimes, the meeting shone a spotlight on positive media developments.

"We are in an actual flowering of journalism, right now," stated **Julia Angwin**, Pulitzer Prize Winner, Investigative journalist, Co-founder and Editorin-Chief of The Markup. She outlined journalists' efforts to reveal abuses of power by big tech and push for greater accountability.

Among the positive developments is the global reach of collaborative media investigations to uncover high-level corruption.

Matthew Caruana Galizia, Investigative Journalist, Lead Engineer for the Paradise Papers Investigation and 2020-2021 EYL40, told the group that collaborative media investigations were leaving public authorities behind. Regulators, civil administrations, the police and judiciaries must

be strengthened to follow up on cases brought to light by the press.

More robust structures are also needed to protect journalists, added Caruana Galizia, whose mother, journalist Daphne Caruana Galizia, was murdered in 2017 as she investigated links between politics, crime and corruption in Malta.

"There is a lot more that can be done multilaterally to ensure that journalists are no longer targeted," he argued. "We are not saying journalists are a privileged class, that they need these special privileges ... it's really about protecting the interests of the public that journalists are serving with their work."

As well as shielding journalists physically, the media needs economic security at a time when sales and advertising are under intense pressure from online competition. Here too there was a candid discussion on the use of state-support, as opposed to privately-funded journalism – and their respective downfalls.

"On taxpayers' money to fund journalism as a public good, we need to really have a great, indepth effort to understand what are the necessary safeguards to avoid the capture of journalism," insisted **Guilherme Canela**, Chief of Section for Freedom of Expression and Safety of Journalists at UNESCO. "It is possible."

#### The view from here

Meeting in the Western Balkans gave the European Young Leaders the chance to hear perspectives from the region on Europe's key challenges. Several speakers called on the EU to unblock membership accession processes for Croatia's neighbours to the east.

"The Balkans are part of Europe, and they should be part of the European Union," insisted **Geert Cami**, Co-Founder and Secretary General of *Friends of Europe* as he kicked off the three-day debate.

That issue was taken up by Prime Minister Plenković. He warned that long delays in enlargement are opening opportunities for other players, including Russia, China and Turkey, to expand their influence in the region. "Where is the anchor? That should be the EU," he added.

Plenković also called for a wider European approach to help countries in the region cope with the energy price crisis triggered by Russia's war in Ukraine. "The problem with this crisis is that nobody knows how long it is going to last," he remarked. "These costs need to be shared further ... we clearly need a wider European solution to help our societies and our economies."

Suggestions from President Macron and others for an overhaul of the treaties underpinning the EU received a lukewarm response. "These

debates are fun for the Brussels bubble ... for the citizens they are certainly incomprehensible and not attractive at all," Plenković told the group. "Treaty changes ... we are not excluding them, but we need to focus on what is essential," he added, mentioning the energy crisis, inflation and other economic impacts of the Ukraine war.

Marko Pavić, Chair of the Committee on Regional Development and European Union Funds at the Croatian Parliament and 2019 EYL40, listed the benefits of EU membership for his country since it joined in 2013, for example in helping recovery since the COVID pandemic. Bringing in the other countries of the Western Balkans would strengthen democracy in the region. "We need to rethink our democracy and how to tackle all the crises and all the challenges," Pavić said. "For the stability of this region, we need the Western Balkans, they need to have a European future."

The European Young Leaders also met with **Tomislav Tomašević**, Mayor of Zagreb, to discuss the need for a rehaul in leadership styles. The election of this 40-year-old environmental activist last year broke the mould of politics in the Croatian capital and could serve as a model for others seeking change. "As a politician you have to be a realist, not believing in fairy tales, but always believing you can change stuff," Tomašević said.

"We were completely honest in what we are saying. We had many opportunities to use shortcuts to positions of power and we refused to do it," he added. "If we win, we want to do it without any debts to any kind of interest groups. We want to do it on our terms"



#### Student unrest

Tomašević has support from many younger voters, but Croatian students who met with the European Young Leaders the following day at the University of Zagreb's Faculty of Geodesy expressed a lack of trust in politicians as a group.


"The biggest problem in our society in Croatia is how the politicians put on top of the government are absolutely wrong, people don't have a clue for what they are voting for," complained one student.

A quick online poll with the audience found that three-quarters of those in the room don't trust government, and a ranking of the level of government they trusted more placed the European Union before local and national government. A similar proportion had no expectation politicians will act to reduce the impact of the Ukraine war or climate change.

That lack of faith in democracy appears particularly dangerous when Europe is under attack from authoritarian Russia. "This is the most complex, dangerous security environment that we've had since the end of the Cold War," warned **Benedetta Berti-Alberti**, Head of Policy Planning in the Office of the Secretary General at NATO, as she addressed the joint gathering of EYL40s and students.

Russia's attack shows that Europe cannot take freedom and democracy for granted and must invest in defence, security and resilience she said. "You start to underappreciate the value of all this, of freedom and of democracy and I think you also underappreciate their fragility," Berti-Alberti added. "Democracy today is under attack."

Politicians must shoulder some of the blame for citizens' lack of trust, acknowledged **Jesse Klaver**, Member of the Dutch House of Representatives, Leader of the Dutch green party GroenLinks and 2018 EYL40.

"Politicians are not always fair, not always clear about the trust and about problems. Most of the time politicians ... try to say things that people like," he said. "With all the threats we have in front of us, we need to be honest."

The students were not convinced, one even suggesting that the current capitalistic system had failed and that some elements of communism needed to be reinstated in the region, for its own good. Others complained about NATO, feeling that it had failed to intercept a military drone which crashed near a university campus in March.

This conversation, on international defence alliances and the feeling of being left to fend for oneself, was a recurrent theme, even though the European Young Leaders came to the defence of NATO and democracy. "NATO is incredibly powerful and incredibly intelligent and sometimes we need to put our trust in this alliance," said **Zanda Kalniņa-Lukaševica**,

Parliamentary Secretary of the Latvian Ministry of Foreign Affairs, Trustee of *Friends of Europe* and 2017 EYL40.

Several EYL40s urged the students to channel their discontent into activism. **Ivan Štefunko**, Founding Chairman of the Progresívne Slovensko party, Consultant in Innovation Policies and 2015-2016 EYL40, encouraged them to take matters into their own hands and "Go and drink a beer this evening and make a plot to change your country". He referred to his experience founding a progressive party in 2017, fueled by a similar sentiment. This in turn led to the election of Zuzana Čaputová, Slovakia's youngest and first female president just two years later.

#### Art takes a stand

The seminar also had a strong hard look at art beyond its usual parameters and instead as a powerful and bonding protest tool. Held at the Museum of Contemporary Art (MSU), this plenary discussion was led by a trio of engaged artists: **Kate Sutton**, Commissioning Editor of international reviews at Artforum; **Jasmina Cibic**, Filmmaker, sculptor and artist from Slovenia and 2014 EYL40; and **Lina Džuverović**, Curator and Lecturer in Arts Policy and Management, Department of Film, Media and Cultural Studies, Birkbeck College, University of London; Founder of Birkbeck's Decolonial Feminist Forum.

"Protest is more than saying 'I disagree'; protest is I disagree, and I will do something ... We are

all more powerful in our own way than we think", said Džuverović, as the EYL40s examined how art can resist oppression, violence and war and succeed in bringing opposites together. However, it also looked at how regimes try to appropriate art for their own ends and discussed controversial issues including how to fund the arts and the pros and cons of cultural boycotts.

Sutton pointed out that definitions of art and protest have blurred. "Protest can take many forms," she said. "Is it productive to draw lines between art and protest? In this context, I would argue that it is, only in so much as structuring something as art can lend it protection that simple protest action might lack."

She showed examples of protest art including acts of self-mutilation by Russian artist Petr Pavlensky; actions that landed Russian performance art group Pussy Riot in jail; and Sanja Iveković's work *Triangle* showing the artist drinking whiskey and appearing to masturbate on the balcony of her Zagreb apartment as Yugoslav leader Josip Broz Tito visited the city in 1979.

Džuverović sought to look beyond art as a protest against things to examine ways it can make a proactive difference. Exploring the #artistsupportpledge initiative, which raised over £30 mn for artists through online sales as the pandemic shut down galleries and fairs, she brought forth the power that art had in using whatever frameworks exists to bend the rules. Created to support artists in the midst of the pandemic, it has now used its art sales to support Ukraine.

Other effective examples included the Rebuild Foundation set up to regenerate areas of South Side Chicago by restoring vacant buildings and launching cultural initiatives; and the Belarus Free Theatre in exile whose performances support political prisoners, education and democracy.

"We all have agency. We all can do something, even if it seems very simple and very small, it is possible," Džuverović told the group. She appealed for art and culture initiatives to be taken up and expanded into other spheres of civic life.

Art can fill gaps in society, Cibic explained. "Every artist compensates what is lacking, there is a lack in society, there is a lack of utopias, lack of history, there are a lot of lacks around us today, but I want to particularly focus on the lack of political national authority," she said. She went on to explain why that made the shutting down of cultural spaces during the pandemic particularly damaging.

Now, it is important to get back to cultural institutions and, especially to get children back into museums, galleries and theatres. "We need together to learn how to be audiences again."

As in the discussions on education and the media, there was considerable debate on funding for the arts and the roles of the state and private sector. Questions were raised about the possible restrictions on artistic freedom from government or business patrons. This linked into the EYL40 working group on Arts and Culture. The working group published last year its policy briefing, Prioritising arts and culture in a renewed social contract. The recommendations of the report aimed to strengthen Europe as a leader in artistic creation, anchor cultural practices and celebrate the diversity of European identities. They carry one clear message: "We all - as citizens of Europe – should reassess what we value as Europeans and explore the vital role that culture can play in fostering a sense of shared values and an inclusive vision for the future of our continent" and have since led to a series of discussions including the role of digitalisation and AI in supporting the arts.

**Aleksandar Nikoloski**, Vice-President of the Democratic Party for Macedonian National Unity and 2022 EYL40, bemoaned the lack of funding alternatives that leaves artists in eastern Europe poor and dependent on the state.

"We should think in eastern Europe how to open funds for artists because it's impossible to survive in the market," he said. "If you have no funds, you cannot create. If you cannot create you cannot protest."

Several participants said artists cannot afford to be too picky about where their funding comes from. "You can't eat your CV," said Cibic.

Debate also turned to the question of restrictions on art from Russia. While sanctions on business are generally positively supported there was less consensus on a ban on culture or restricting access to Russian art, artists or historical heritage. Questioning the efficiency of banning Russian youth from competing, **Alexandra Dariescu**, Award-Winning Concert Pianist, Producer of 'The Nutcracker and I', Creative Entrepreneur and 2018 EYL40 also questioned the precedent and impact of banning Russian composers from being played.

However, **Agnesta Filatovė**, Executive Director of the Vilnius International Film Festival (VIFF) and 2020-2021 EYL40, explained the reasoning behind the decision to pull Russian movies from the festival programme in the weeks after the invasion. "It's not the time to make a focus on

Russian culture," she said. "It's quite painful from the artistic side, but there is no grey when there is war, it is only black and white."

Others made a parallel with the sporting and cultural boycott of South Africa which are widely viewed as helping to end the apartheid regime.

#### **Connections**

The Zagreb seminar maintained the EYL40s tradition of hosting a number of successful roundtable exchanges. Peer-learning roundtables were held on themes ranging from 'Cyber for Democracy' headed by **Gundbert Scherf**, Co-Founder, President and COO of Helsing - a security and artificial intelligence company – and 2022 EYL40; 'Why Hackathons Work' with Marko Russiver, Founder and CEO of Grantful and 2022 EYL40; and 'Leveraging AI for intelligent health solutions' by **Loubna Bouarfa**, Founder and CEO of OKRA Technologies and 2022 EYL40.

Valentina Diouf. Professional athlete and 2022 EYL40, briefed on the difficulties faced by women in professional sports. As a female volleyball player, she faces discrimination in wages and work conditions. Women are paid less and are often forced to accept amateur status which deprives them of social protection and makes them vulnerable if they become pregnant. "Why should my time not have the same value as their time?" she asked. She also hammered the fact that athletes who complained often find themselves left off the team or unable to find a club, feeding into this discriminatory culture. "They feel they don't even have to give us a rational explanation" for the discrimination, she said.





A second round featured **Arancha Martínez Fernández**, Founder of It-willbe.org, Co-Founder and CEO of The Common Good Chain and 2022 EYL40, who explained how to tackle poverty through innovation; **Ruben van Zwieten**, Founder and Reverend at De Nieuwe Poort and 2019 EYL40 discussed his experience as a pastor and social entrepreneur; and **Samir Abdelkrim**, Founder EMERGING Valley, Member of the Digital Strategy Group of the Africa Europe Foundation and 2020-2021 EYL40, talked about building a new partnership between Africa and Europe through innovation.

**Tamara Srzentić**, Montenegrin Minister for Public Administration, Digital Society and Media, and 2022 EYL40, shared her experience in building digital services for the public in California and in Montenegro, after

being called into government in 2020. The work included streamlining government websites to make them easier for the public to use and reforming government services to get the right people in the right place to provide optimal services. "Good government in the digital age should be about people. They are the core," she said. "The biggest lesson was to start with the user's need."

#### **Conclusion**

The EYL40 Zagreb 2022 seminar showed that the COVID-imposed hiatus has done nothing to dim the dynamic spirit of the EYL40 programme. Meeting in the context of security, climate, health and economic crises, over 50 young leaders from 24 countries joined together to brainstorm solutions to some of the key challenges facing European society today. They came from diverse backgrounds, including politics, tech, civil society, science, sports, health, journalism, the arts, academia, diplomacy and religion.

The debate and flow of ideas clearly lived up to the ambition of Friends of Europe, as Cofounder and Secretary General **Geert Cami** had urged at the beginning of the seminar – fostering a vision for the European Young Leaders to find inspiration in each other's experiences, and to seek a renewed sense of hope in such difficult times.

The EYL40s proved once more their willingness to engage in these conversations and, at times, thorny topics for the good of Europe and future generations. Committing to a more constructive political future, a Europe of tomorrow that includes the Balkans, sustainable equality in arts, sports and academia, and greater dialogue with citizens were some of the necessary tools put forward to rework today's most intractable problems. Since the seminar, many have come

together to put pen to paper and join hands — prime evidence that collaborative leadership and the EYL40 are the key to a fair, sustainable and inclusive tomorrow.

"This is all about letting people with different backgrounds and political beliefs, from different cultures, come together ... create bonds of trust that hopefully will then lead to collaborative action," Cami explained. "To work on the challenges of the 21st Century and tackle them in a more constructive and holistic way."

Those ambitions will be advanced when the young leaders meet next, September 8-10 in Lisbon.

The European Young Leaders represent a promising European leadership from all over the continent and with a wide variety of backgrounds including politics, business, civil society, academia, arts, science and the media. From trailblazing biochemists to budding political leaders, and from dotcom entrepreneurs to NGO 'stars' who are shaping the social and environmental policies of tomorrow, the European Young Leaders are a unique community that crafts innovative responses to European challenges and positively affects the lives of future generations.

Every year, they meet during two 3-day seminars that take place in symbolic European cities, joined by decision-makers, stakeholders and key European actors, to discuss issues of common concern and develop concrete proposals and recommendations to tackle the challenges facing Europe and its citizens.

The relaxed tone and out-of-the-box nature of the European Young Leaders (EYL40) programme have brought about salient and open discussions that have facilitated the development of a strong network of committed Europeans.

In 2016, Guillem was named among the ten most prominent scientists worldwide by Science Magazine and one of TIME Magazine's 100 most influential people in the world.

Witold is a former Polish athlete, who currently heads WADA in its mission to lead a collaborative worldwide movement for doping-free sport.
